CPE Classifications Continuing Education Program Colegio de Farmacéuticos de Puerto Rico

A. Type of Activity:

Knowledge: These CPE activities are primarily constructed to transmit knowledge (i.e., facts). The facts must be based on evidence as accepted in the literature by the health care professions.
