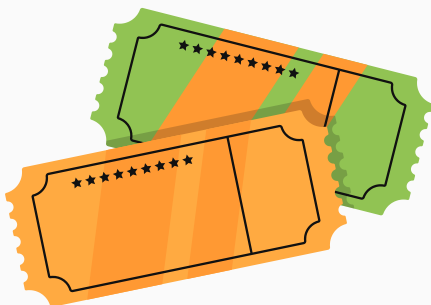

- Only paid reservations are guaranteed.
- Cancellations made on or before July 15, 2026, will incur a \$350.00 fee.

- No-shows will be charged the full room rate.
