REGISTRATION

We will be accepting pre-registrations in our offices until August 3, 2026 (subject to availability of requested course). We will use the postmark date of your pre-registration as evidence. Pre-registrations received by mail postmarked after Monday, August 3 will not be processed.

All registrations will be processed in the order received. Pre-registration priority order is as follows: online payments will be accepted first; mailed pre-registrations will be accepted second; in third place are pre-registrations done in person.

Pre-registration received without payment will not be accepted. After receiving your pre-registration, you will receive a confirmation of the courses in which you have been properly registered. If you send your pre-registration coupon by email, confirm or verify with our offices to make sure it has been received. To avoid duplicates, do not re-send registrations by mail.

PAYMENT

You can make your payment by check or money order payable to the Colegio de Farmacéuticos de Puerto Rico. In addition, you can book by credit card, internet or in person by cash or ATH.

If you currently have any debt (license, returned checks or other) with the Colegio de Farmacéuticos, it must be paid in full prior to your pre-registration.

CANCELLATIONS (Conference Pre-registration)

Cancellations or changes must be made on or before Monday, August 3, 2026 for an 80% refund of the total amount paid. The remaining 20% will be used to cover administrative expenses. After Tuesday, August 4, 2026 no refund requests will be accepted for NOT attending educational activities.

There will be no cash refund after August 3, 2026. In case you cannot attend and cancel your registration, only 80% of the payment will be applied for future continuing educations. For this, you must submit a written justification indicating the reason why you will not be able to attend the conferences. and evidence, if required.

CPE CLASSIFICATIONS

A. Type of Activity:
